- 1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending Foxy Locks Doggie Daycare. I agree that my dog(s) must be restrained at all times whether it is leased, kenneled, or carried. I understand that this is for my safety as well as my dog(s). I agree to accept responsibility for any injury caused to another person or animal if my dog(s) is/are not restrained and does not hold Foxy Locks, LLC liable.
- 2. I further understand and agree that in admitting my dog(s) to the daycare, Foxy Locks Doggie Daycare's staff have relied on my representation that my dog(s) is/are in good health and has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
- 3. I further understand and agree that Foxy Locks, LLC and their staff and volunteers, will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog(s)' attendance and participation at the daycare.
- 4. I further understand that all complaints must be placed within 24 hours of visit. After that time period it is impossible to determine if the problem was caused by an outside source or from daycare. I will not hold Foxy Locks, LLC and their staff responsible for any sickness or injury caused by my dog(s) during their visit, accidental death due to natural or pre-existing health condition, or natural disasters (fire, storm, flood, etc). I agree that dogs can sometimes receive minor cuts and scratches at daycare and any problems that develop with my dog(s) will be treated as deemed best by staff and volunteers of Foxy Locks, LLC at their sole discretion, and that I assume full financial responsibility for any and all expenses involved. If determined that Foxy Locks, LLC is at fault for any issues that have risen, then a discount or refund will be applied. Treatment, if necessary, will be provided by their veterinarian at no cost to me.

I certify that I have read and understand the policies of Foxy Locks Doggie Daycare as set forth on the preceding pages. I understand that my dog(s), my guests, or I may be videotaped or photographed and that these images become the property of Foxy Locks, LLC. I agree to release, hold harmless, acquit, will

indemnify and forever discharge the corporation from all, and in all manner of action and actions, suits, damages, judgments, executions, claims, and demands whatsoever, in law or in equity, which I or any person I have with me during daycare at Foxy Locks, LLC. I have read and understand the conditions, and statements of this agreement, including the following:

APPLICATION: All dogs must have a complete, up-to-date and approved application on file. A pass is valid for 3 months from date of purchase.

DAYS AND HOURS: Monday through Saturday from 7:00 a.m. to 6:00 p.m. The Daycare is not an overnight facility. Staff goes off duty at 6:00 p.m. and there is a \$1.00 per minute charge for any pet left after 6:00 p.m. RESERVATIONS: Required. Cancellations same day will be charged full fees. No show appointments will be required to pay for missed appointment and prepay for next appointment before being able to schedule.
